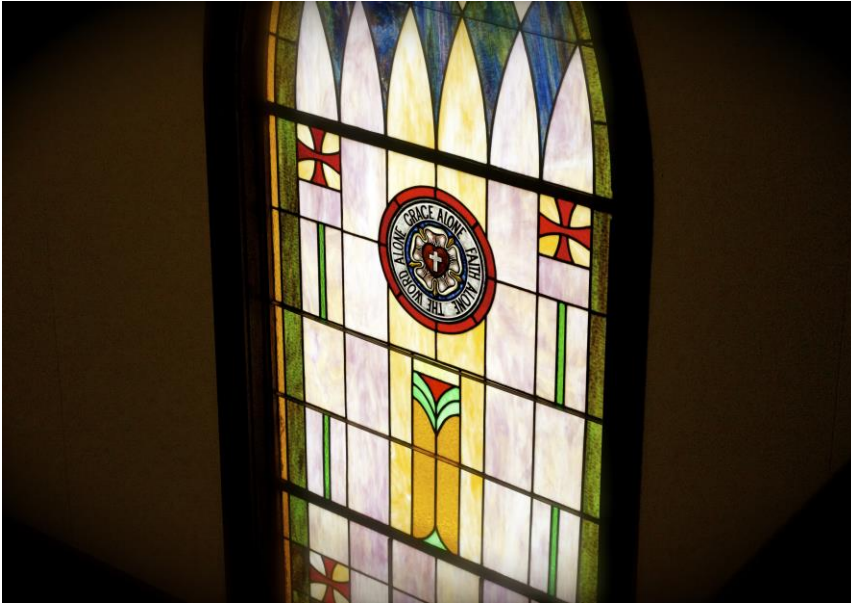

Sunday, March 19, 2023

The meeting was called to order by Kristina Wisner.

The agenda was approved by Barb, seconded by Mitch.

The Secretary's report for February was read. Chris motioned to approve; Mitch seconded - MC.

The Treasurer's report was submitted by Treasurer Jodie. The ending balance of our General Fund for February was \$58,842.99. Jim motioned to approve; Barb seconded - MC. We also decided to submit our annual budgeted donations to Reach Out for Warmth and the Roseau Area Food Shelf.

Buildings and Grounds:

1. Prep & paint 1,000 gallon LP tank
2. Clean up main entrance & Bell Tower (weed, trim shrubs, etc.)
3. New audio equipment for Livestream - TV downstairs - double check to make sure functional.
4. Replace front door - Chris will check with Allen & Shannon Monsrud about measurements and obtain a bid.
5. Replace/repair fallen ceiling tiles in basement classroom - Curt and Jim check on tiles.
6. Sale of excess tables & chairs - offer to members first. In Spring inventory will be taken and a decision will be made on how many tables/chairs to reduce by.
