### **Our Redeemer's Council Minutes**

Sunday, January 7, 2024 (Originally scheduled to be held 12/17/2023)

In attendance: Jim Christiansen, Jodie Davy, Chris Rhen, Mitch Rhen, Barb Broten, and Kristina Wisner.

The meeting was called to order by council president Kristina.

A Devotional message was read by president Kristina.

The Agenda was revised to add items. A motion to approve the revised agenda was made by Jodie, seconded by Barb – M.C.

The Secretary's Report was submitted by Barb. It was amended and a motion to approve was made by Chris, seconded by Mitch – M.C.

The Treasurer's Report was submitted by Jodie. It was suggested to give a year-end bonus to Mary for her work leading and preparing services. A motion to approve was made by Jim, seconded by Barb – M.C.

#### **Building and Grounds:**

1. Prep & paint 1,000 gallon LP tank
2. Clean-up main entrance & bell tower (weed, trim shrubs, etc.)
3. New Audio equipment for livestream – We have a new phone for livestreaming.
4. Sale of excess tables & chairs
5. Replacement TV in the front of the Church has been installed.

#### **Old Business:**

1. Pastoral Vacancy – No updates at this time
2. Haiti Mission – We will have a men's breakfast on January 21 st to replenish the \$1,000.00 given on 11/1/2023. We've also decided to give the remaining \$900.00 balance in the miscellaneous category of Mission Outward giving to Haiti. Motion made by Jim, seconded by Barb – M.C.

3. Old Front Doors - Chris has a use for the doors if no one else wants them. A motion was made by Mitch to give the doors to Chris, seconded by Jim – M.C.

New Business:

1. Budget Review – These items were voted on collectively. The motion was made to accept by Jim, seconded by Mitch – M.C.

a. Earned Sick & Safe Time is a new requirement passed by the MN Legislature and is effective 1/1/2024. We have decided to front-load 80 hours per employee at MN's minimum wage rate of \$8.85. This \$2,124.00 was added to the budget.

b. The salaries for the employees has been updated as follows:

- Janitor - \$3,600.00 annually
- Secretary - \$3,000.00 annually
- Treasurer - \$1,000.00 annually

c. The funds to pay for the TV at the front of the Church and the new front doors will be taken from the memorial account as well as the "Repairs & Maintenance" category. We will move \$5,400.00 to the general fund to pay the bill when it is received and leave a small balance in the Memorial account.

2. Turn in Annual Reports by January 21 st , or ASAP.

3. Nominating Committee: Kristina Wisner, Mitch Rhen & Barb Broten

4. Month of February Services – Mary will be gone the month of February. She will prepare the services, but we need leaders. Kristina and Carol will lead during the month.

Other remarks or concerns: None at this time.

Next meeting is Sunday, January 28th, 2024 briefly following the annual meeting to elect council officers.

Barb motioned to Adjourn; Chris seconded – M.C.

The meeting closed with the Lord's Prayer.
